## POLICY COMMITTEE TIME LINES April 27, 2009

The Policy Committee provides the following information to assist the community in understanding the status of policies in development for the 2008-2009 production year.

## Policy Proposals in Progress

Batches 158 and 159, which were approved by the Governing Board on April 16, 2009, were the final batches of policy proposals developed for the 2008-2009 production year. While the Committee continues policy proposal consideration and development, there will be no additional policy proposals distributed for comment until after the July 2009 *Common Manual* update is available to the FFELP community.

## **Policies Approved, Bulletins Issued**

The following chart represents policy changes approved by the Governing Board after April 17, 2008, the cut-off date for the last paper and electronic Manual update. These changes will appear in the July 2009 printed and CD (ECM) versions of the *Common Manual*. They will also be incorporated into the *Integrated Common Manual* updates that are posted on the *Common Manual* website each month. Common Bulletin Language has been or will be distributed for all of the new policies, as listed below.

<sup>1</sup>Policy proposal 1041 was originally distributed for community comment in February, 2008, deferred by the Committee for additional research, and redistributed in Batch 150. The remainder of Batch 150 was approved by the Governing Board in April, 2008, and is included in the July 2008 Common Manual update.

<sup>2</sup>Policy proposals 991 and 997 were previously distributed in Batches 146 and 149. Policy proposal 1055 was previously distributed in Batch 151.

<sup>3</sup> Policy proposal 1003 was previously distributed in Batch 147.

<sup>4</sup>Policy proposal 1085 was withdrawn from Batch 156 based on community comments and moved to considered.

<sup>5</sup>Policy proposals 1092 and 1095 were originally distributed in Batch 157, deferred for further research, and forwarded to the Governing Board for approval along with Batch 159 on April 16.

<sup>6</sup>Policy proposal 1121 was withdrawn from Batch 159 and moved to radar. Policy proposal 1123 was deferred for additional research and development. Policy proposal 1127 was moved to considered, and the text incorporated into Policy proposal 1109 in Batch 158.
